Gundri	Mandar-Panthawada National Highway (NH-168) on Left Hand Side (From Old RTO Post 2 KM toward Panthawada)	2 Km

Site Requirement for Setting up CNG Station:

- The plot should have a clear and undisputed title for setting up a CNG station.
- The plot should be on main road (National Highway [NH] /State Highway [SH]).
- The plot should be around 2000 Square meters and having minimum frontage of 40 meters.
- No overhead power/telephone lines and underground Oil/Gas/Water Pipeline.
- Land should not be the part of right of way of government road, SH or NH road.
